

Crystal's Corner - Activities of the Board

Adair County SB40 has nine Directors serving three year terms and are appointed to the Board by the Adair County Commissioners. The Board of Directors meets on a monthly basis to review staff reports and finances, to conduct Board business and to approve staff requests in accordance with Agency policy. This past November, the Board of Directors of Adair County SB40 held their annual retreat. Every year the Board members hold an annual retreat to discuss the status of the organization and plan for the coming year. One of the purposes of the retreat is to review the Mission, Vision, Values and Ethical Principals of the organization. The Board members reauthorized the following without change:

Our Mission - Why do we exist? The MISSION of the Adair County SB40 is to encourage in ADVOCACY, promote INCLUSION, and provide essential RESOURCES to assist people with developmental disabilities to live selfdetermined lives.

Our Vision - What is the future we seek to bring about? Our VISION is to see people's ABILITIES and change the world so that everyone can live their best life.

Our Values:

- SELF-DETERMINATION Having opportunities, respectful support, and the authority to exert control in one's own life with decisions that are honored and the opportunity to succeed or learn from failure.
- COMMUNITY The importance of community in the lives of people with developmental disabilities and the importance of people with developmental disabilities in the life of the community with emphasis on collaboration and belonging.
- EQUALITY Ensuring that all people have equal opportunities to make the most of their lives and talents and that no one should have poorer life chances because of the way they were born, where they come from, what the believe, or whether they have a disability.

The Board also reviewed the Strategic Plan of the organization for the coming year. The Board referred the goals and focus of the Strategic Plan to Staff Committee for prioritization and recommendations to the members.
